I am writing to inform you that the school was informed, that one staff member from Verne W. Critz Elementary School tested positive for COVID-19 on January 15, 2021. The staff member was last in school on January 8, 2020.

In accordance with the District's reopening plan, we have notified the Suffolk County Department of Health, the agency responsible for case investigation and contact tracing in Suffolk County. In review of the schedule of the staff member, it has been determined that there has been no close contact with any other students or staff members during the infectious period. Therefore, self-quarantine is not necessary.
