Call to Order

**1. CALL TO ORDER (7:02 p.m.)**

Board of Education President Gregory Miglino, Jr., called a Business Meeting of the Board of Education to order at 7:02 p.m. The meeting took place in the Boardroom of the Central Administration Building, 189 No. Dunton Avenue, East Patchogue, New York. Long Island Advance, South Shore Press and Newsday were notified of this meeting. Notices were also sent to all school buildings and the local libraries.

**4. PUBLIC PARTICIPATION**

*Beth S.:* Q re: status of decision to classify BHS dance group as Club or Team? Read a prepared statement requesting classify the dance group as a Sport; said this issue should have been addressed by the end of last year.

Public Participation

*Gregory Miglino:* item was not on this evening's agenda because more information was needed; this evening, the Superintendent will be bringing forth more information on this issue

*Superintendent Walsh:* said he has heard nothing negative regarding the dance group, and that Section XI does not recognize dance groups as a sport; said the group will be classified in the appropriate category.

*Donna D.:* Q re: elimination of Teaching Assistants and the Reading First grant?

*Gregory Miglino:* Federal Grant for Reading First was eliminated by the State; the district did not decide to eliminate the grant [\$1.2 million]

*Raymond Walsh:* The district received late notice about the unavailable funding; reductions in Reading First were made in June; but coaches will remain and continue to train staff for the balance of this year.

*Donna D.:* spoke about the passed [working] budget and \$20 million in Caithness money...

*Gregory Miglino:* The district will get \$120 million from the Caithness project over a 20-year period; however, we've only received \$1.1 million so far. The New Superintendent is working with staff regarding the TA issue. Every member of this Board feels "horrible" about eliminating positions, but it there were no alternatives.

*Dr. Anthony Donatelli:* Thanked the Board of Education for his appointment as school physician for the past 3 years; stated he has no hard feelings about its decision to appoint another physician, and that he would be happy to assist the district again if needed.

*Gregory Miglino:* Thanked Dr. Anthony Donatelli for his understanding.

*Phyllis V.:* Q re: Board's justification for numbers on the line-by-line budget? says numbers do not correspond with the number of Teaching Assistants; Q re: an explanation and supporting documentations?

*Gregory Miglino:* the responsible person is no longer with the district; budget adjustments have been made; referencing Q re: supporting documentation – said the budget advisory committee did not submit a report because they too were unable to get the information that was needed.

*Phyllis V.:* Q re: use of the Caithness money?

*Gregory Miglino:* The money we received form the Caithness project will be applied to the 2009-2010 school year.

*Kevin Kirk:* believed TAs was budgeted and was initially told that 15 TAs would be eliminated; however, on June 8<sup>th</sup>, was shocked and disappointed to learn that the actual number is 24; said late notice was received that the State would be cutting funding for Reading First, from \$1.4 million to \$200 thousand; request: number of TAs on staff prior to receiving the Reading First grant.

*Kathy M.:* [in response to Mr. Kirk]: One TA was assigned to each Kindergarten and each First Grade classroom.

*Debbie J.:* TAs has been assigned to Kindergarten and First Grade classrooms since 1989; can understand cutting the 15 TAs that were paid through the Reading First grant, but eliminating the additional 9 TAs is a "shock".

*Allison S.:* referenced an email message that was sent all 9 Board members and the superintendent – said she only received six [6] responses; and that all six responses were different regarding what would be happening with the TA's.

*Sean Clark.*: Explained how TAs were assigned and paid under the Reading First grant; provided insight on his plans for utilizing TAs this fall but stated that he must wait for student data before a decision can be made.

*Kevin Kirk.*: Q re: the number of days per week a TA is in a Kindergarten class?

*Sean Clark.*: Response: TAs is in Kindergarten classrooms every day; however, TAs is assigned to First Grade classrooms for reading blocks.

*Toni Huffine.*: Q re: how "low end" students will be accommodated?

*Sean Clark.*: Response: low end students will be provided with reading teachers; one class reached the benchmark last year, therefore the classroom was not assigned a TA; this allowed us to provide another classroom with a second TA, based on students' needs.

*Pam S.*: Q re: whether 1:1 Aides will be shared?

*Gregory Miglino.*: assured Pam S. that 1:1 Aids will not be shared; also said he hopes no one will leave this evening's meeting thinking that the Board does not care; said "we" all have families in the district; but unfortunately money is not available to fund all of our needs.
