6. PRESENTATION

Dwayne Adsitt, Interim Assistant Superintendent for Curriculum & Instruction, and Kimberly Branfeld, Shared Data Expert / Staff Developer from Eastern-Suffolk BOCES, gave a presentation on Academic Performance - Grades K – 12.

Comment: Mr. Adsitt stated that the Regents exam scores for Math, Science and Social Studies have improved over the last year; and in some cases, there were marked improvements.

Q: Last year's scores?

A: Scores are examined closely, and then strategies are developed before moving forward

Q: How is proficiency levels addressed?

A: Working with teachers to develop strategies that will provide support and services for students

Q: Types of data available to teachers?

A: Benchmarks are provided for grades 3, 4 and 5; data is analyzed, students' weaknesses are identified and gaps are addressed.

Q: Timeliness of results from State exams? And Q re: types of materials provided to teachers for testing students' skills?

A: Particular tools purchased; individual meetings conducted; data evaluated

A: Teachers have materials for addressing gaps: assessments, grading, examining areas for additional support, and the reading department and librarians working with students.

Comment: Board member said: would prefer County-wide data – requested data is provided to all Board members.

Q: How scores compare with other school districts?

Q: Do scores meet the benchmarks?

A: Assessments are State-approved; benchmarks are being met.
