8. PUBLIC PARTICIPATION

Susan Roth: Q re status of bids for next year's busing, and whether language for retaining drivers and workers has been added to the bid specs?

Gregory Miglino: have received some advice re: the mandates for the amount of people that might adversely affect the bid; and that a retention of 65% of the present workforce might somehow trigger an automatic vote, or something to that affect; said we anticipate bids to be completed and going out within the next two weeks; also, this is an executive session issue; however "we" will do all we can to retain jobs; spoke of neighboring districts paying on the high side of \$13 thousand and others paying as low as \$10 thousand more per bus; also spoke of the State's current financial situation; said no preference will be shown; hoping to reach an understanding about workers retention.

Michael Bilecki: spoke of recent media attention to budgets; Q re whether the Board is looking to combine services with other districts as a way of lowering the budget? *Gregory Miglino*: there are no plans for merging at this point; four months ago, the Board approved negotiations and meeting with the Patchogue-Medford School District for shared services; there have been meetings with the Superintendent and the Village of Bellport re: entering into shared services agreement with the Town of Brookhaven.....

Toni Huffine: merging of districts is something she feels the district needs to move toward; spoke of the "huge amounts" of salaries each district pays...

Carl Moodt: says the district has to be careful with whom it merges; does not want our district to inherit Patchogue-Medford's problem – their serous financial issues and recent layoffs – added that shared services is "something different".

Resident: said she too attended the play at the high school, and that it was very well done; Q re whether the district is planning any programs in honor of Black History Month?

Superintendent Walsh: the Principals do have something planned; it will happen before the end of the month.

Gregory Miglino: says if nothing is planned; something will be put in place. *Spencer Stickley*: Q re: status of the Caithness money?

Gregory Miglino: has been receiving investment updates from our treasurer; the Caithness check has not yet arrived; our presentation tonight will address some of your questions.

Spencer Stickley: Q re agenda item no. 6-J – rate of pay for retired South Country teachers to provide home instructions to students? says retired teachers will be providing the same services.

Resident: asked the Board whether the rest of public participation can be postponed until after Mr. Buzzeo's presentation?

Nelson Briggs: the History Club is actively meeting, although this is not reflected on the report.

Toni Huffine: said on October 8, 2008 she voted for Joe Cipp's salary of \$700 per day; but at the time questioned before voting, the amount Mr. Cipp received during his prior employment; and that the superintendent's response was this is what Mr. Cipp received; so based on that she voted in favor of the resolution; but when she went back and discussed this issue with Board members, etc., realized that amount was not what Mr. Cipp received and subsequently foiled the information. Mrs. Huffine stated that Mr. Walsh then stated at the following Board meeting that Mr. Cipp has previously received \$600 per day---Q re: when and if the Board met on that issue to take a vote? Gregory Miglino: when the issue was raised before the Board, the wrong information was given; "we" then asked that a research is conducted. The same individual who first provided the wrong information, and who held the same position of authority and would be able to look at those records, came back and reported to "us" the new figure and that new figure was reported to you; that information was also incorrect because it was originally \$700; Mr. Miglino stated that it was not until the superintendent himself was able to pull the records that "we" found out that was not the correct figure. Mr. Miglino noted that the amount was based on a different job title, then said the Board is aware of the rate of pay earned by that individual.

Toni Huffine: stated that \$700 a day is a "phenomenal amount" of money for "us" to be paying out; and that this is not directed at Joe Cipp but anyone in that position; continued by asking how the Board justifies Mr. Cipp making almost more than the annual salary of someone in that position? Mrs. Huffine reiterated that she would not have voted in favor of that resolution had she known ... *Gregory Miglino*: told Mrs. Huffine she did vote on that item and that the resolution passed unanimously.

Carl Moodt: asked that discussion on this item is moved to executive session...?; said salaries are being discussed in public session; also said meetings should be following Robert's Rules and the very polices that the Board has devised.
