RESOLVED, that the budget of the South Country Central School District, Suffolk County, New York, for the fiscal year 2010-2011 in the amount of \$109,624,261 be adopted and the requisite portion thereof be raised by taxation on the taxable property of the District.

PROPOSITION NO. 2

RESOLVED, that the South Country School District be authorized, effective with the 2010-2011 school year, to provide for full (no minimum mileage limitation) transportation (in lieu of the present limits of (1/2) miles for students in grades K-3; (1) mile for students in grades 4-8; and (1 1/2) miles for students in grades 9-12) for all district students, grades K-12, at the approximate additional cost of \$263,072 and that the necessary amount therefore be raised by a levy upon the taxable property of the School District at an estimated additional tax increase of \$1.00 per \$100.00 of assessed valuation.
