## 2. <u>PUBLIC HEARING</u> <u>AMENDMENT TO CODE OF CONDUCT</u>

## **Board President Correa read the following, Section VII, Alternative Instruction, of the current Code of Conduct:**

## SOUTH COUNTRY CENTRAL SCHOOL DISTRICT CODE OF CONDUCT SECTION VII. ALTERNATIVE INSTRUCTION:

When a student of any age is removed from class by a teacher, or a student of compulsory attendance age is suspended from school pursuant to Education Law §3214, the District will take immediate steps to provide alternative means of instruction for the student. Alternative instruction will be provided to all students of compulsory school age suspended from school whether it is In School Suspension or Out of School Suspension. In addition, alternative instruction will be made available to any student over the compulsory attendance age who presents a sincere desire to complete his / her high school education.

# The following proposed change to the Code of Conduct, Section VII, Alternative Instruction, was then read:

## 3. DISCUSSION

Board President Correa opened the hearing for public discussion, comments or questions.

In response to questions, School Attorney Christopher Guercio, explained that under the current New York State Education Law 3214 & 3205, school districts are obligated to provide alternative instruction to students until the end of the school year in which the student turns 16 years old, which is the compulsory age. Beyond that age they may, but they're not obligated to. The District's current policy self -mandates the Board to provide alternative instruction even to students beyond the compulsory age. The revision to the District's policy, will give the Board the flexibility to provide it on a case by case basis, but they are not obligated beyond the compulsory age. This does not apply to Special Education students.

There being no further comments or questions, the Public Hearing ended at 7:25 pm.

The Board will continue to enforce a four minute time limit, but the public will be asked to stop speaking or to leave should it become disruptive.

We, the South Country School Board, have been advised by our counsel to not release district funds to CIA Construction Group, Inc. Furthermore, we have been advised by our own Asst. Superintendents for Business to also not release funds to CIA.

CIA never executed certain contracts and was unable to provide the required Performance and Payment Bonds. CIA was the only one of over twenty contractors engaged by the District, on its recent construction program, who failed to execute its contracts and provide acceptable bonds. In addition to not acquiring the proper legal documents, our construction managing firm, Park East Construction, has advised us that some of the work done by CIA is unsatisfactory. Furthermore, the District has been contacted twice by the Department of Labor and instructed to withhold \$334,000 to any future payments to CIA.

When all legalities and acceptable work are completed, we expect to resolve our differences with CIA. Until then, as financial stewards of the District, we will continue to follow the advice of counsel, our Business officials, and our construction managing firm."

Trustee McKenna read a statement expressing her concerns about literature passed out at the last Board meeting by a community member, which contained disparaging comments regarding her children. She stated that while she, in the position of Board member, can expect such comments, she takes exception regarding her children, who have succeeded based on their own merit.
